2024 MONTHLY MAINTENANCE FEE: \$330

The Board of Directors approved and adopted the 2024 budget at the November 15 Budget Adoption Meeting. **The monthly maintenance fee will be \$330 starting in January.** IF YOU ARE ENROLLED IN AUTOPAY WITH TRUIST BANK, **YOU DO NOT NEED TO DO ANYTHING ... THE AMOUNT WILL BE AUTOMATICALY INCREASED.** If you pay by check, or through your personal online Banking, or by credit card, YOU WILL NEED TO UPDATE THE AMOUNT TO **\$330**.

UPCOMING ELECTRIC PEDESTAL REPLACEMENT

At the November SRI Board Meeting WEATHER CHEK ELECTRIC of Tarpon Springs was approved to do the replacement of nineteen electric pedestals in the park. The work will begin as soon as possible and units that will have replacements will be notified in advance of specific dates.

As decided at the board meeting the project will be funded by the Electric Pedestal Reserves and the loan fund. MORATORIUM ON REQUESTS TO REPLACE GRASS WITH STONE/GRAVEL

To allow for the creation and board approval of guidelines for the installation of stone/gravel to replace grass, the Board voted at the November meeting to place moratorium on acceptance of applications for such changes. This is temporary until the guidelines are accepted and approved by the board. The Architectural Committee is currently working on the guidelines.

SUBMITTING "REQUESTS TO MAKE ADDITIONS OR CHANGES FORMS"

As stated on the form, these must be submitted **NO LESS THAN TWO WEEKS PRIOR TO THE PROPOSED START DATE** of the requested change. It is strongly advised to ALLOW MORE than TWO WEEKS for projects that involve additions, driveways, or patios. Drawings that accompany applications should be neatly rendered on 8-1/2 by 11-inch paper, legibly labeled with all measurements specified.

DOG WALKING: RESTRICTIONS APPLY IN PARK

DOGS MAY <u>NOT</u> BE WALKED ON THE STREETS OR SIDEWALKS WITHIN STONEHEDGE. Dogs should not be loose on any lot or common area. According to our Rules and Regulations, dog walking is authorized in ONLY ONE AREA of the Park - <u>on the TWO STRIPS OF COMMON</u> <u>AREA ALONG THE EAST MAIN ENTRANCE UP TO</u> <u>THE CODY'S WAY SIDEWALK</u> and only between the hours of 7:30 AM and 8:30 PM. Observations of residents walking dogs outside the designated area and dogs unleased on lots or common area have been reported. PLEASE BE ON NOTICE THAT WALKING DOGS IN ANY AREA OTHER THAN THAT DESIGNATED IN OUR RULES, WILL RESULT IN BOARD ACTION, AND POSSIBLE FINING.

And please remember, a dog must always be leashed and under the direct control of its handler ... even on Golf Carts.
