DOT COMPLETES REQUESTED ROAD IMPROVEMENTS AT FRONT EXIT

Flex Posts have been installed at the outgoing exit as the final phase of improvements requested of the DOT to repair a hazard at the road's edge. In March, a deep hole was filled; sod was placed along with a painted stripe in April; and finally, the Flex Posts were installed on May

23rd. The re-concreting of the sidewalk south of the Stonehedge entrance and the addition of a guard rail was also completed. **PLEASE BE AWARE OF THE FLEX POSTS as you make the turn onto US 19.**

AUTOPAY UPDATE

We have 187 residents enrolled in Autopay ... worry-free about late fees if their payment is not postmarked by the 3rd of the month! So, JOIN IN! The Autopay sign-up form is available at the Office, at stonehedgeonthehill.org, and in this issue!

If you still prefer to MAIL-IN your payment or DROP IT OFF AT THE STONEHEDGE OFFICE - PLEASE ALLOW ENOUGH TIME FOR THE PAYMENT TO BE MAILED FROM THE STONEHEDGE OFFICE TO TRUIST IN ORLANDO WITH A POSTMARK NOT LATER THAN THE 3RD OF THE MONTH. Remember, payments dropped off at the Stonehedge Office, still need to be MAILED to Truist for processing. So again, be sure to drop off your payment in plenty of time for it to get to Truist with a postmark not later than the 3rd of the month.

HOME SALES

Since January there have been **12 home sales in the Park** ranging in price from **\$95,000 to \$185,000. The median price being \$127,500.**

Speaking of Home Sales ... if you are thinking of selling, please contact the Stonehedge Office for a **List of LOCAL TITLE AGENTS that are MOST FAMILIAR with the special aspects of closing a Stonehedge sale.** Not all Title Agents are familiar with the specific paperwork, transfer of vehicle titles, etc., that should be part of the process. This can result in DELAYS FOR SELLERS and BUYER as well as incomplete documents to the Buyer at closing. If you are selling your unit, contact the Stonehedge Office for more information before you choose a title agent.

SECURITY REMINDER – BACK GATE

Security is everyone's responsibility. It is a breach of that responsibility to provide gate remotes to contractors and service providers, or to open the rear gate for vendors, delivery trucks, or unknown visitors. PLEASE use your gate remote responsibly.

Do You Have That in Writing?

Please remember that APPROVAL for Exterior Changes or Additions must be IN WRITING.

There is no provision for VERBAL approval or authorization to make a change or addition to the exterior of a unit. **Always complete and submit the required REQUEST FOR CHANGES OR ADDITIONS FORM at least two weeks prior to the anticipated start of any proposed change or addition.** The form is available in the Office, at stonehedgeonthehill.org and in this issue. If in doubt as to whether your plans require approval, contact the Office.

ROAD CHECK

-PLEASE OBSERVE STOP SIGNS in the Park by coming to a **complete stop** and **proceeding SLOWLY** when turning onto our NARROW roads...Golf Carts included.

-**Street Parkers:** please **be sure your parked vehicle is a safe distance from street corners so that it is not blocking visibility of the road to vehicles turning onto that road from side streets.**

-And last, but NOT least, observe the Park's **15 MPH Speed Limit – all the time – and on all park roads.**

- x I want my friends and family to embrace my reality. If I think my spouse is still alive, or if I think we're visiting my parents for dinner, let me believe those things. I'll be much happier for it.
- x don't argue with me about what is true for me versus what is true for you.
- x and I am not sure who you are, do not take it personally. My timeline is confusing to me.
- x and can no longer use utensils, do not start feeding me. Instead, switch me to a finger-food diet, and see if I can still feed myself.
- x and I am sad or anxious, hold my hand and listen. Do not tell me that my feelings are unfounded.
- x I don't want to be treated like a child. Talk to me like the adult that I am.
- x I still want to enjoy the things that I've always enjoyed. Help me find a way to exercise, read, and visit with friends.
- x ask me to tell you a story from my past.
- x and I become agitated, take the time to figure out what is bothering me
- x treat me the way that you would want to be treated.
- x make sure that there are plenty of snacks for me in the house. Even now if I don't eat I get angry, and if I have dementia, I may have trouble explaining what I need.
- x don't talk about me as if I'm not in the room.
- x don't feel guilty if you cannot care for me 24 hours a day, 7 days a week. It's not your fault, and you've done your best. Find someone who can help you, or choose a great new place for me to live.
- x and I live in a dementia care community, please visit me often.
- x don't act frustrated if I mix up names, events, or places. Take a deep breath. It's not my fault.

- x make sure I always have my favorite music playing within earshot.
- x and I like to pick up items and carry them around, help me return those items to their original places.
- x don't exclude me from parties and family gatherings.
- x know that I still like receiving hugs or handshakes.
- x remember that I am still the person you know and love.

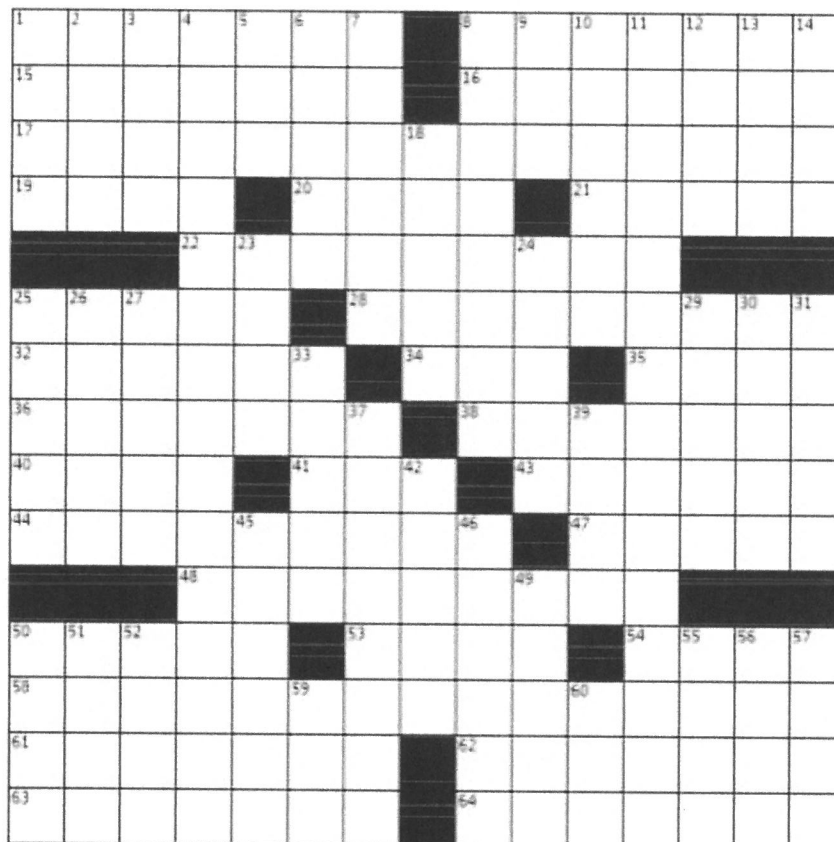

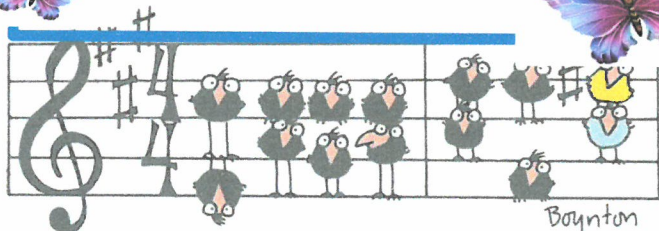

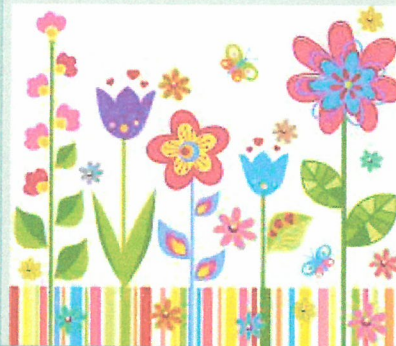

- Changes in painting colors from the current **MUST** be accompanied by chart samples (base & trim).
- The Board of Directors has the final say on the interpretation of the association building code guidelines and approval of your request.
