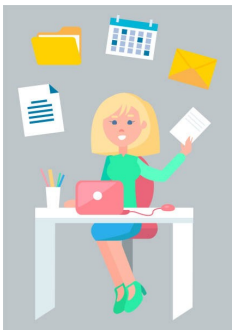

- For 2024, there are four positions to elect.  
An **INTENT TO RUN FORM** is included in this issue and is available at the Stonehedge office.

### 2024 Monthly Fee ... \$330

If you're enrolled in Autopay, there is nothing you need to do.

However, if you pay by check OR through personal online banking be sure to make the **ADJUSTMENT TO \$330 per month**. And remember that for payments that are mailed, they must be received BY TRUIST ASSOCIATION SERVICES no later than the 5<sup>th</sup> day of the month or they are considered LATE and subject to a \$25 delinquent fee and interest charges.

**PLEASE TAKE NOTE:** payments received at the Stonehedge Office are then mailed to Truist Association Services. So be sure to leave sufficient time for your payment to reach Truist by mail before the 5<sup>th</sup> day of the month.

**BUT WAIT! ... AUTOPAY eliminates all these concerns! The monthly payment is debited from the designated account on the 3<sup>rd</sup> day of the month! No more writing checks...No**

stamps...No risk of LATE FEE! An AUTOPAY enrollment form is included in this issue!

### NEW YEAR ... SAME OLD ISSUES...

#### SPEEDING & STREET PARKING need EVERYONE's ATTENTION and EFFORTS.

All vehicles, INCLUDING GOLF CARTS and motorized bikes, MUST NOT EXCEED the posted 15 MPH SPEED. So please **SLOW DOWN ... and remind your visitors and guests to do the same.**

**STREET PARKING** is something else everyone can have a direct impact on by double-checking that visitors and service providers to your unit **PARK ON THE STREET**. If they do not, **ASK THEM TO MOVE THEIR VEHICLE OFF THE SIDEWALK.**

### VISITING DOGS to NON-DOG LOTS

This situation **REQUIRES WRITTEN APPROVAL IN ADVANCE** and the following apply:

- A **WRITTEN request must be submitted at least 10 days in advance** of the visit.
- The maximum number of visiting dogs per unit is two (2) and the visit cannot exceed 7 days in a 30-day period.
- Proof of current vaccination records must accompany the request and **the visiting dog/dogs must comply with ALL OTHER PET RULES and restrictions.** (See page 18 of *Rules & Regulations*).

Please keep in mind that VISITING DOGS to perimeter lots must meet all PET RULES and are required to have Vaccination Records submitted in advance to the Office.

**It is recommended to submit requests for visiting dogs to a non-dog lot as far in advance as possible to allow sufficient time for review of the request and a written response.**

### OFFICE HOURS...

As a reminder, the **Office Hours for resident assistance are Monday to Friday, 8 AM to 12 NOON**. Even though I am in the office after 12 noon, those hours are intended to allow working without interruptions on administrative, accounting, real estate and other such tasks. **EMAIL is always available for questions and requests and the OFFICE DROP BOX can be used for submitting forms and payments.**

Thank you for using the 8 am to 12 noon hours for assistance. As always, assistance after 12 noon can be arranged **BY APPOINTMENT** in advance. (Cont. next page)

**IMPORTANT NOTE regarding submitting REQUESTS TO MAKE CHANGES OR ADDITIONS**

At this time while the Architectural Committee is drafting operational and procedural changes, ***Requests to Make Changes or Additions forms should be submitted for review at least 3 to 4 weeks in advance of the proposed start date.*** **Be sure your requests include the required details, and drawings and measurements if appropriate to avoid further delays. All drawings and sketches that accompany requests must be on a SEPARATE 8-1/2 by 11-inch paper.**
