FACT SHEET

Most of us want a peaceful retirement.. There are just a few negative folks who enjoy "poking the bear," creating unrest and negative feelings and reactions.

The reasons are many for stopping rumors: FACT: "Rumors and false statements can and will hurt an Association's reputation in the market and adversely affect property values." We have always been a in the top tier of associations, a pretty tight- knit group here in Stonehedge, looking out and caring for each other. We hope to continue our legacy of caring about our friends and neighbors and not let a few petty gossipers hurt any one of us.

FACT: Residents are bound by formal rules or laws of Stonehedge Residents Inc, City of Tarpon Springs, and Pinellas County. We have our management team and The Board to help enforce the rules and laws mentioned. If you don't like the rules, by all means, please get involved and work to have them changed with a positive approach.

RUMOR:"It has been rumored that shutting the wells down will burn out your sprinkler system.

FACT: DON'T WORRY...This is 100% wrong. The system is low voltage and is not affected at all. *****

RUMOR: the recent water restrictions rumor says ""they can't touch us- we are private and have our own wells."

FACT: This is 100% INCORRECT! We fall under the City of Tarpon Springs jurisdiction. *****

RUMOR: Recently we heard a rumor that the water restrictions were removed.

FACT: They were for ONLY Pinellas County--*NOT* for the City of Tarpon Springs (which includes Stonehedge) (Code enforcement has verified this fact to the manager.) *****

RUMOR: "They are ripping you off for the timers."

FACT: We charge \$55 (the cost is \$49.99 plus tax \$53.49) *****

RUMOR: The recent Laundry room project was been monitored and it took over 2 months to complete. **FACT**: Actually the project started on July 17 when the Laundry company moved the dryers. The project was completed before July 25. *****

WE NEED YOUR HELP.... Simply ask or take the time to verify the information yourself before you spread it. Not only does the internet offer explanations (as to the damage to timers with the wells off) but phone calls to the City (to verify the sprinkler restrictions and guidelines) or even asking when projects will be started and keeping track on your own as to the time for completion.

If you hear some story about how YOUR money is being spent or why certain procedures have been implemented by anyone other than someone who is directly involved with those decisions, it would benefit you to ask and verify rather than waste your time being angry over nothing, or even worse spreading those false statements. Call your Board representative or the Manager for the facts. If you don't like what you hear, get involved, there is a process for change available to you.



Managers Korner OCTOBER 2017

Who woulda thought, who woulda known that for a 24-hour period in September, we were facing what could have been the most terrifying and for some, it was the most terrifying time in their lives. A Hurricane that brought winds and rains that topped 100MPH!!!. No matter what damage was done to homes, we were lucky. We at a park were prepared for what we encountered. Our clubhouse electric was not lost and a "Thank You" to Jerry and Donna Kinsey, that 60 or so people were able to feel the comfort of neighbors going through the same.

We have a group of absolutely wonderful and tireless volunteers led by Joyce Lester, that provided hot meals -Breakfast, Lunch and Dinner for all those who were without power or who just wanted a meal. Our pool and pool shower was open for those who wanted to cool off a bit until power was restored to those 170 or so homes without electricity.

For those who were not here I can truly say you missed what Stonehedge is all about. Granted you missed the storm, the nervousness, the fright, and maybe some damage, but I feel those who were here saw firsthand that working together and use of common sense is our ultimate goal to make a better living experience here at Stonehedge.

As with every experience whether good or bad we

find out what may be changed – what has to be changed and what we should leave alone. Some items that will make the next one- and there will be a next one- a less stressful event for those who put time in to keep this place running.

- In advance of storm, sign in sheets need to be prepared, Residents need to be informed to notify the office if they evacuate from the park, residents staying in club house need to register, residents staying in someone else's unit need to notify the office.
- Residents need to turn their porch light switch to the on position when the power goes out so they know when it is restored.
- Residents who will be gone for any part of the Hurricane season need to EMPTY their refrigerators and freezers.
- 4. All awnings must be put down and secured to the home.
- 5. ALL residents need to have a working key to their unit and a current working phone number on file with the office.
- 6. It is not the responsibility of the person watching your unit to secure the awnings or clean out your freezers unless you have made prior arrangements for them to do it. If you have no prior arrangements make them.

The Board also has seen some improvements that we can make to the clubhouse as well – just in case we do lose power completely for some length of time as well as some other time saving procedures. This was a joint effort and only a joint effort will make a rough experience a smooth one

Ok now the business end:

With a season coming to an end we will set the tone for the rest of the year and the coming year in the next few months. I encourage residents to attend Board meetings, starting again regularly 9/27 with the Budget meeting 11/15.

Don't be in shock – fees have not been increase for 4 years and we have no control over 92% of our budget. We have also completed over \$600,000+ worth of major work and repairs and depleted our Reserves

and loan fund to pay for these much-needed upgrades. Sink holes and retention pond unforeseen issue happened, and I do not need to tell you - we are getting older. Our electrical pedestals are 40+ and wells are over 20+ years old.

Currently only 2 homes are for sale. What a difference from when there were 20 homes listed. Our home values have continued to get better. Thank you to those who have helped.

When I say clear on the issue – state if it's an electrical, plumbing or other service required issue.

"ANY MEDICAL OR FIRE ISSUES CALL 911

Protocol is for me to call you back as soon as I get the message from either you direct or from Ameri-Tech who will notify me.

NEVER and I say **NEVER** feel like a pain in the ass for repeated calls.

If you do not hear back from either me or Ameri-Tech within ½ hour **PLEASE CALL BACK** until you do.

You can also notify a Board member who is on site. If you have any questions on the process please feel free to call me. Thank you.

DROUGHT STRESSED LAWNS

Turfgrass plants are 70% to 75% water, which indicates the importance of moisture in maintaining a vigorous, healthy, growing plant. When grasses lose more water through the leaves than they absorb through the root system, the plants become stressed.

Drought Stress Symptoms

The early stages of drought stress are seen as turfgrass changing color from bright green to a dull gray or blue-green color. Footprints and lawn mower wheel tracks remain for a



period of time and the grass does not spring back upright. As plants begin to wilt the grass blades roll or fold. With additional stress, the turf loses its green color and becomes yellow, then tan. A tan color indicates drought dormancy.

Drought Stress Damage

Grass plants that are in drought stress are often damaged by foot traffic and mowing. Do not mow lawns that are in drought stress. The grass is not growing, and the plants have less moisture content to protect the cellular structure from collapse and permanent damage.

Broadleaf weeds and weedy grasses in drought stressed lawns may outgrow the turf and create an uneven appearance. However, even mowing the lawn at a high cutting height to cut off tall weeds may still result in lawn damage. When a lawn is dry, mower wheels often leave stripes across the lawn when the grass blades are broken and damaged by the weight of the wheels.

Factors Affecting Drought Stress

Some turfgrasses such as bermudagrass and tall fescue have more tolerance of low moisture conditions than other grasses. Centipedegrass, bentgrass, and annual bluegrass are more prone to drought stress, and will lose green color quickly when soil moisture is low.

Heavy clay soils and sandy soils are not favorable for growing turf during periods of low moisture. The clay holds the moisture so tightly that grass roots cannot retrieve moisture, while sandy soils have a low moisture holding capacity.

Turf roots growing in thatch rather than in soil can result in a grass more prone to drought stress. Thatch is a layer of dead but undecomposed roots and stems above the soil. Thatch acts like a sponge. It quickly absorbs rainfall, but also dries out rapidly, leaving plant roots dry even after rainfall or watering.

Lawns mowed shorter than recommended for a grass type may have a shallow root system growing in the soil. A shallow root system dries quickly even when thatch is minimal.

Managing Turf During Drought

Water the lawn once grass begins to discolor and wilt. If it is not possible to water sufficiently to keep grass green, water the lawn with at least 1/2 inch of water every 7 to 14 days. This light watering will help keep the plants alive even if they are dormant. Do not mow the lawn during hot weather when signs of drought stress are present.

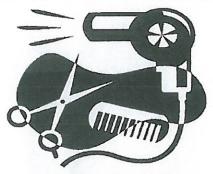

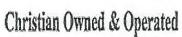

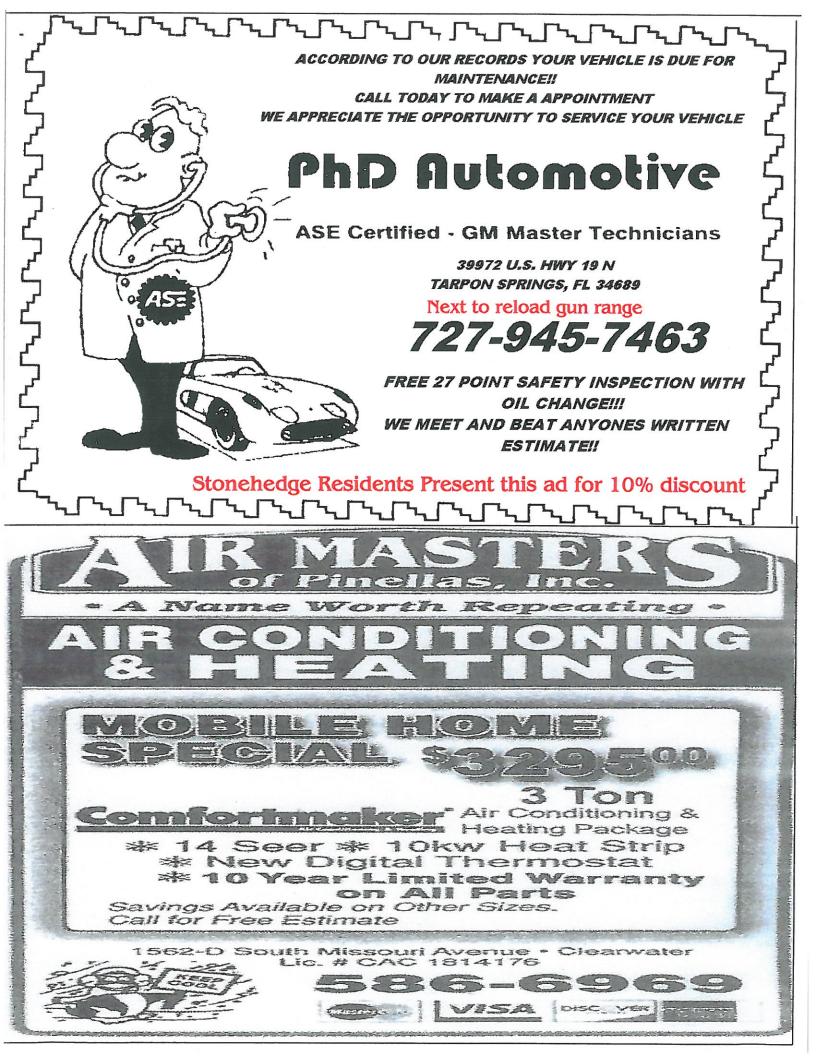
